Within SEGRO's Transformation & Technology Department, this role sits in the Business Analysis team, but can be assigned to work on programmes across any areas within the department.

Within SEGRO, a Senior Business Analyst may be asked to take on small/medium projects, supporting the design authority team, and/or owning some operational technology processes and must be able to do so independently and be resilient to change and uncertainty.

- Testing, validating and documenting development solutions.
- Supporting the management of projects, including acting as project manager for smaller activities.

To support the development and operation of the business analysis team, through:

- Supporting, and at times leading, the definition of best practices and ways of working
- Supporting fellow business analysts working in other business areas
- Reviewing and approving business architecture and process design proposals made to the Design Authority.
