### What are we looking for?

We are currently looking to appoint a Data Analyst is required to support the Property Management Reporting (PMR) team to fulfil its core day-to-day functions and to facilitate the modernisation of reporting as part of wider business transformations that are underway.

Reporting to the Senior Data Analyst in the PMR team, the Data Analyst will have a hands-on role and will be comfortable both presenting ideas to senior management and coding/creating solutions.

The role's principal accountabilities will be in;

- Providing monthly property information for operational and Group reporting purposes, including the Operations report, the KPI Board pack and all property statistics.

- Analysing data and explaining changes and variances in key metrics, for actual, forecast and budget data, including various ad hoc scenarios and modelling.
